SHOW RULES

1. Entries can be emailed or mailed to Sue Webb.
2. All exhibitors **MUST** purchase an exhibitors pass for \$12.00. One helpers pass is allowed for an additional \$12.00.
3. All ribbons must be picked up day of show.
4. Check in starts at 10 am, August 7, 2010 for cooped rabbits.
5. Show room opens at 6 am on show day, August 8, 2010.
6. All stock must be permanently and legibly earmarked.
7. Cooped rabbits will be released between six and eight pm on Tuesday, August 10, 2010.
8. Substitutes must be same sex and class.
9. All complaints and protests must be in writing, signed, and given to the show committee.
10. BOB & BOS rabbits may be substituted in coops at end of show.
11. The Lake County Fair is not responsible for rabbits or exhibitors.
12. The Lake County Fair has the right to reject any entry for lack of merit.
13. Any rabbit left until Tuesday must display a coop card with owners name, breed and sex of rabbit, and ear number on it.
14. All ear number changes **MUST** be made between 6 and 8:30 am day of show. **NO EXCEPTIONS!** Only 5 changes allowed. Come prepared! Exhibitor is responsible for making sure the changes are made! Blank ARBA remark cards will be available for use.
15. **ALL NSF CHECKS WILL BE ASSESSED A \$30 PENALTY FEE!**
16. Selling rabbits after show must go thru Superintendent/ Show Secretary.
17. **NO ALCOHOL ALLOWED ON GROUNDS!** Anyone with alcohol will be asked to leave and lose all premiums they may have won.
18. Keep all exits clear of cages and people.
19. **NO SMOKING IN BUILDING OR AT EXITS.**

RULES FOR SELLING

1. All exhibitors are responsible for selling their own rabbits.
2. All cooped rabbits must have gone over the judging table.
3. All sold rabbits must have receipt with breed and ear number on it.
4. Rabbits sold before Tuesday must be replaced with same breed, sex, and class.
5. Replacement rabbits can be sold, but not picked up until noon on Tuesday.
6. In Doe & Litter cages one bunny must remain with doe until noon on Tuesday. No replacement of bunnies.
