- Heifers must have valid registration papers, or will be shown as commercial.
- Purebred Heifer class will be shown by age.
Junior Yearling - Jan, Feb, March
Summer Yearling - April, May, June
- Commercial heifers will be shown by weight.
- Steers will be classified by breed and shown by weight.
- Prospect Steers show by weight-breeds combined.
- Prospect Heifers show by weight-breeds combined.
- Breed Classes must have 2 entries to form a Class. All single entry will be moved to AOB or crossbreed.
- All cattle are to be stalled in the beef barn only.
- Generators are encouraged.
- No Alcohol permitted on fairgrounds.
- Bedding must be wood shaving or straw. Wood shavings are available for purchase. Please NO bark.
- Not responsible for accidents or stolen property.
- All decisions by superintendent are final.
